## INDEPENDENT AUDITORS' REVIEW REPORT TO THE BOARD OF DIRECTORS OF PARSVNATH ESTATE DEVELOPERS PRIVATE LIMITED

- 1. We have reviewed the accompanying Statement of Standalone Unaudited Financial Results of **PARSVNATH ESTATE DEVELOPERS PRIVATE LIMITED** ("the Company") for the Half-year ended 30 September, 2014 ("the Statement"), being submitted by the Company pursuant to Clause 29 of the Listing Agreement for debt securities with the Stock Exchanges. This Statement is the responsibility of the Company's Management and has been approved by the Board of Directors. Our responsibility is to issue a report on the Statement based on our review.
- 2. We conducted our review of the Statement in accordance with the Standard on Review Engagements (SRE) 2410'Review of Interim Financial Information Performed by the Independent Auditor of the Entity', issued by the Institute of Chartered Accountants of India. This Standard requires that we plan and perform the review to obtain moderate assurance as to whether the Statement is free of material misstatement.
